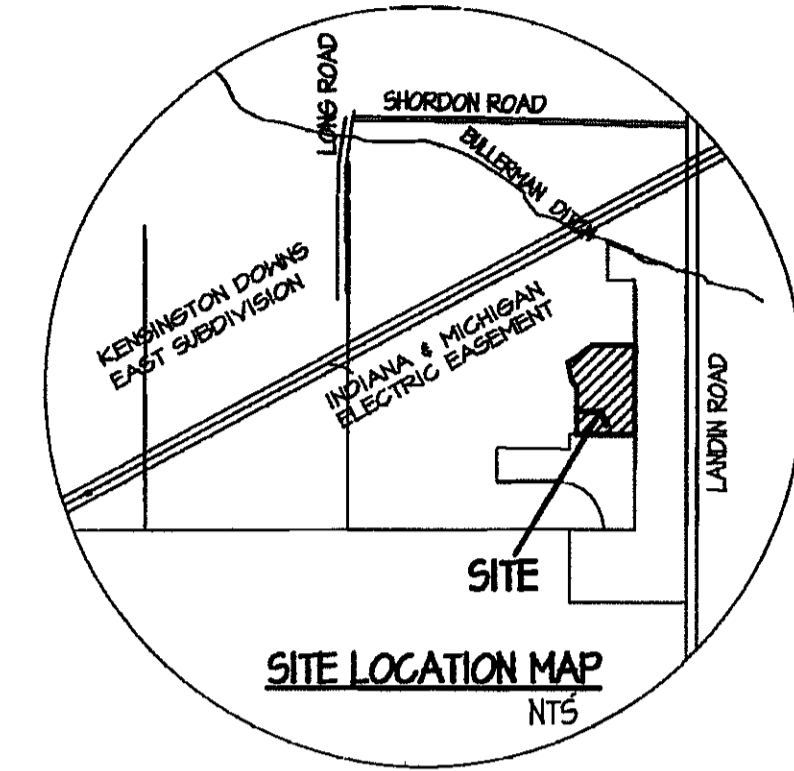

DESCRIPTION LANDIN PARKE, SECTION II-PHASE 2

A parcel of land located in the Southeast One-quarter of Section 35, Township 31 North, Range 13 East, Allen County, Indiana and more particularly described as follows:

Commencing at the southeast corner of Section 35, Township 31 North, Range 13 East; thence South 89 degrees 58 minutes 55 seconds West along the south line of the Southeast One-quarter of said Section 35, a distance of 685.66 feet to the southwest corner of Landin Parke, Section I as recorded in Plat Cabinet F, page 30, in the Office of the Recorder of Allen County, Indiana; said point also being the southeast corner of Landin Parke, section II-Phase 1 as recorded in Plat Cabinet G, page 21, in said Recorder's Office; thence North 00 degrees 01 minutes 45 seconds West along the west line of said Landin Parke, Section I and also being the east line of said Landin Parke, Section II-Phase 1, a distance of 690.03 feet to the southwest corner of Lot 41 in said Landin Parke, Section I; said point also being the northeast corner of said Landin Parke, Section II-Phase 1 and also on the northerly right-of-way of Camdenwood Drive; said point also being the point of beginning.

BEGINNING at the above described point; thence continuing North 00 degrees 01 minutes 45 seconds West along the west line of Lots 34, 35, 36, 37, 38, 39, 40 and 41 in said Landin Parke, Section I, a distance of 633.34 feet to the northwest corner of said Lot 34; thence South 89 degrees 59 minutes 19 seconds West along the south line of said Landin Parke, Section I, a distance of 311.94 feet to the southwest corner of Lot 33 in said Landin Parke, Section I; thence South 42 degrees 18 minutes 56 seconds West, a distance of 107.02 feet; thence South 34 degrees 46 minutes 12 seconds East, a distance of 16.77 feet; thence South 24 degrees 50 minutes 06 seconds East, a distance of 148.68 feet; thence South 00 degrees 45 minutes 09 seconds West, a distance of 140.02 feet; thence South 08 degrees 37 minutes 41 seconds West, a distance of 70.86 feet; thence South 00 degrees 11 minutes 56 seconds East, a distance of 164.90 feet to the northwest corner of said Landin Parke, Section II-Phase 1, and also being on the north right-of-way of Camdenwood Drive; thence along the north line of said Landin Parke, Section II-Phase 1 and said north right-of-way, the following 5 courses: South 84 degrees 37 minutes 58 seconds East, a distance of 128.37 feet; thence on a curve to the right having a radius of 175.00 feet; thence along said curve having an arc length of 8.86 feet and subtended by a chord of 8.86 feet bearing South 83 degrees 10 minutes 57 seconds East; thence South 81 degrees 43 minutes 56 seconds East, a distance of 80.21 feet; thence on a curve to the left having a radius of 575.00 feet; thence along said curve having an arc length of 85.21 feet and subtended by a chord of 85.14 feet bearing South 85 degrees 58 minutes 40 seconds East; thence North 89 degrees 46 minutes 36 seconds East, a distance of 23.29 feet to the point of beginning, containing 4.69 acres of land, more or less.

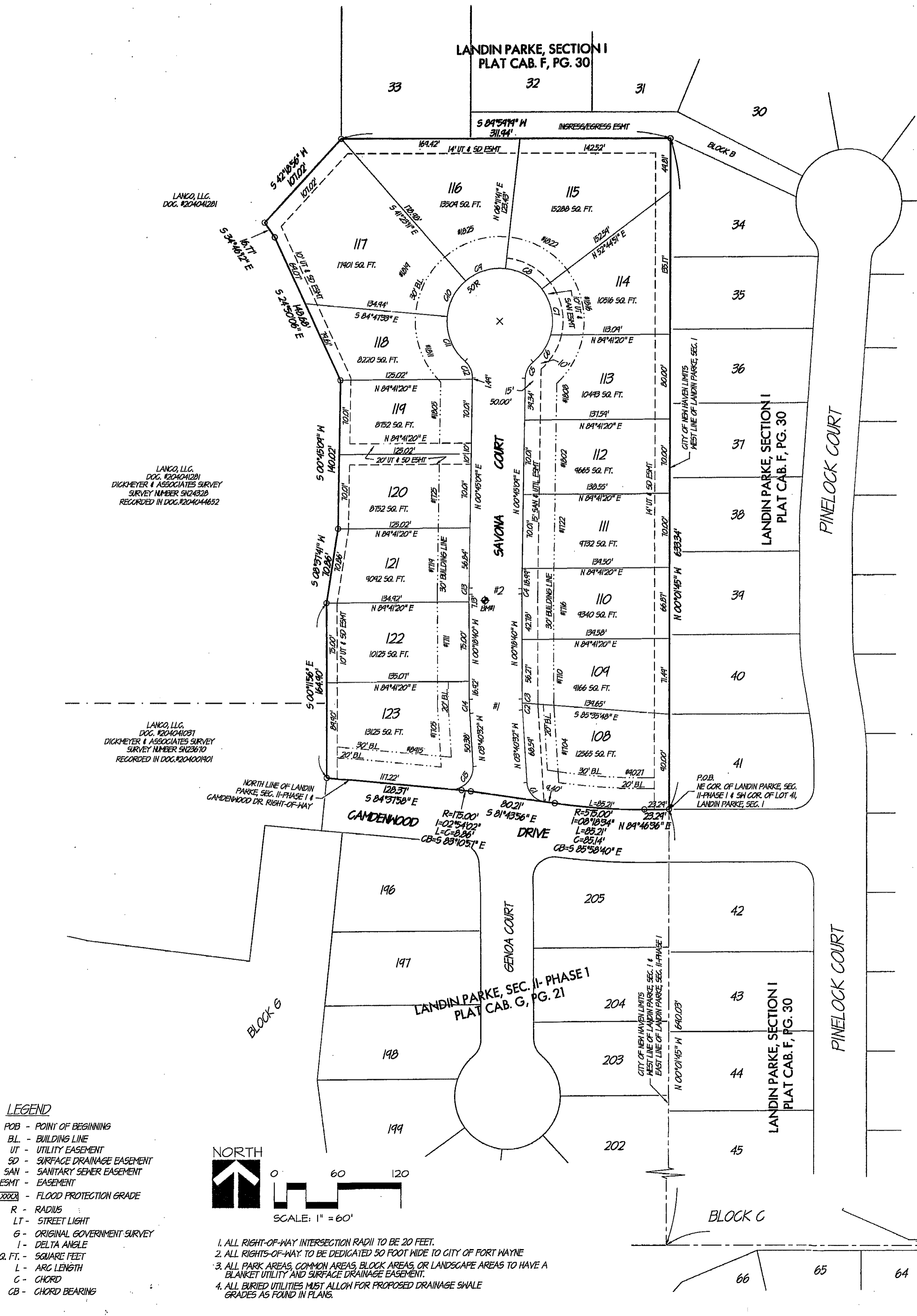
